Covid Support Grant and Summer Holidays

On the 21st June, the government announced a final round of funding to support vulnerable families for the school summer holidays. The level of funding has been reducing since the first grant scheme and we have received less than half the funding from the original Christmas holiday grant. As a result, we have revised our scheme and this letter outlines the offer we will be making to these eligible families during the holidays.

Direct Food Voucher Scheme

In line with previous rounds of grant funding, we have will continue to offer our Direct Food Voucher Scheme. Across the six weeks summer holiday period, 2 supermarket vouchers will be allocated to parents / carers whose children meet the following criteria -

- Funded Childcare and Education for 2-year-olds under the income-based criteria (children aged 2)
- Early Years Pupil Premium under the income-based criteria (children aged 3 and 4)
- Free School Meals (children and young people aged 4 to 16)
- Students in Sixth Forms eligible for Free School meals (young people aged 16-19).

If your child normally receives Universal Infant Free School Meals (in Reception, Y1 and Y2) but you do not meet the criteria for income related Free School Meals, you will **not** be eligible for a supermarket voucher during the summer holiday period.

A detailed list of criteria and information on how to apply for income related free school meals are attached to this letter. If you have any further queries in relation to free school meal entitlement please contact our Education Welfare Benefits Team on ewb.fsm@cambridgeshire.gov.uk or telephone them on 01223 703200.

We will issue each eligible child/young person with -

- a first £30 supermarket voucher by the end of the day on 23rd July
- a second £30 supermarket voucher by the end of the day on13th August

The voucher does not need to be used in a single shopping trip and once claimed will last for at least a year.

We will use information held by schools, settings and the Local Authority to allocate the vouchers using a system called Wonde. Vouchers will be sent by email and text to the nominated parent. If your child is eligible for income related free school meals, or meets any of the other criteria shown above, on or before the 20th July, they will automatically receive two vouchers on the dates set out

above to cover the summer holidays. Any children who become eligible after 20th July up until the 13th August will receive the vouchers and these will be sent as and when we are notified that they are entitled to this support. We are unable to allocate vouchers to new applicants after this time.

Details of the supermarkets which will accept the vouchers and how Wonde works can be found in the frequently asked question document sent with this letter. Please note that **all** unclaimed summer holiday vouchers will be withdrawn on the **24**th **September**. Once you select a supermarket, they will not be withdrawn.

If you **do not** wish to receive a food voucher, please let your school or setting know as soon as possible so that we can reallocate the voucher to someone else in need.

If you have not received your voucher <u>by the 26th July (voucher 1) or the 19th August (voucher 2)</u> or have any queries about this scheme, please contact <u>winter.support@cambridgeshire.gov.uk</u>. Please include in any correspondence the name of your child, their date of birth and which education establishment they attend. This will avoid a delay in responding to your query.

Wider Support

We understand that as a result of the pandemic, there are many families that may need further support who are eligible for the Direct Food Voucher Scheme. We also know there will be families who don't meet the above criteria but are in need of support. Therefore, there is a network of hubs run by the city and district councils that will be able to help you to access further support. Details of support in your local area can be found below:

Appendix 1 – Eligibility for Direct Voucher Scheme

Parents eligible for Funded Childcare and Education for 2-yearolds under the income-based criteria (children aged 2)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance (JSA)
- Income-related Employment and Support Allowance (ESA)
- Universal Credit, and your household income is £15,400 a year or less after tax, not including benefit payments
- Tax credits, and your household income is £16,190 a year or less before tax
- The guaranteed element of Pension Credit
- The Working Tax Credit 4-week run on (the payment you get when you stop qualifying for Working Tax Credit)

Parents eligible for Early Years Pupil Premium under the incomebased criteria (children aged 3 and 4)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based <u>Jobseeker's Allowance</u>
- Income-related <u>Employment and Support Allowance</u>
- Support under part six of the Immigration and Asylum Act 1999
- The guaranteed element of <u>State Pension Credit</u>
- <u>Child Tax Credit</u> (provided you are not also entitled to <u>Working Tax Credit</u>) and have an annual gross income of no more than £16,190
- Working Tax Credit run-on, which is paid for 4 weeks after you stop qualifying for Working Tax Credit

 Universal Credit - your household income must be less than £7,400 a year after tax not including any benefits you get

Parents eligible for Free School Meals (children and young people aged 4 to 16)

In order to qualify you must be in receipt of one of the following benefits:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you applied on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)

Children who get paid these benefits directly, instead of through a parent or guardian, can also get free school meals.

Eligible for 16-19 Free School Meals

Free meals in further education defines disadvantage as students being in receipt of, or having parents who are in receipt of, one or more of the following benefits:

- Income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance (ESA)
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of State Pension Credit
- Child Tax Credit (provided they are not entitled to Working Tax Credit and have an annual gross income of no more than £16,190, as assessed by Her Majesty's Revenue and Customs (HMRC))
- Working Tax Credit run-on paid for 4 weeks after someone stops qualifying for Working Tax Credit
- Universal Credit with net earnings not exceeding the equivalent of £7,400 pa (after tax and not including any benefits you get)

How to Claim Free School Meals

We understand that families continue to live in uncertain times and many are facing changes to their financial circumstances as a result. If you have not previously applied for Free School Meals, or your name has recently changed, and feel you now meet the below criteria, please visit www.cambridgeshire.gov.uk/freeschoolmeals to apply online;

- · Income Support.
- Income-Based Jobseeker's Allowance.
- Income-related Employment and Support Allowance.
- Child Tax Credit but no element of Working Tax Credit and have an annual income (as assessed by HM Revenue and Customs (HMRC)) that does not exceed £16,190.
- If you are supported under Part VI of the Immigration and Asylum Act 1999.
- Guaranteed element of State Pension Credit.
- Working Tax Credit during the four-week period immediately after your employment finishes or after you start to work fewer hours per week.
- Universal Credit with an annual net earned income of no more than £7,400.

Also, schools are continuing to provide support for eligible families, in the form of either food parcels or vouchers, during term-time where pupils are unable to attend due to Covid-19. Your school will be able to confirm the support that they are offering. The form is simple to complete and will give you an immediate response.
